**COVID REQUIREMENTS – Riders, visitors and officials please check in and out using either Nominate QR code or PRARG'S QR Code. There is no longer a paper requirement allowed. All current COVID requirements remain in place.**

**Horse declaration** forms to be handed in at the gate or done online via PRARG's website with Google.

**General:** Catering & coffee van (Jimboomba Netball Association). Please be prepared to ride earlier if required. Warm up/lunging areas clearly defined. **A MAXIMUM** of 10 Minutes in the lunging arena per horse. No-one riding a horse in the lunging yard can take precedence over a horse waiting to be lunged. No public to be standing in those areas. Children to be under control of parents at all times. Please leave a SAE for return of results.

**WARM EQUITTE (10 Minute Arena) –** This is your final warm up – please only do collected work or working paces – no medium/extended paces.

**Horses/Ponies:** Only horses and ponies entered on the day permitted on grounds unless a companion horse is approved by OC.

**WE HAVE MAXIMUM NUMBERS –** Please park with consideration for fellow riders and leave the grounds at your earliest convenience to allow for later riders coming in. Please respect our parking inspector! **Paperless scoring is being used so you do not need to stay on the grounds to get your test sheet. This will be sent to your device electronically.**

**ONLY RIDERS WITH YARDS NEAR WASH BAY WILL BE ALLOWED TO PARK IN THAT AREA.**

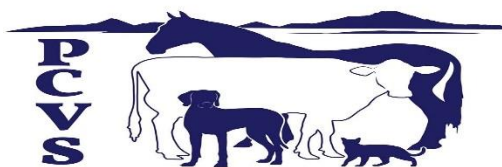

## IMPORTANT BIOSECURITY NOTICE

These measures include:

- Not entering the grounds if you feel unwell or if you are sick.
- A site register recording all participants and support persons that enter the grounds to allow for tracking, tracing and rapid response of required – **THIS IS AT THE GATE ON ENTRY TO THE GROUND – THIS WILL BE VIA Nominate or PRARG QR CODE.**
- Adherence to the current COVID-19 Guidelines as provided by Queensland Health.
- Compliance with physical distancing and hand hygiene
- A completed Horse Health Declaration (HHD) is mandatory and **MUST BE SUBMITTED ON ARRIVAL AT THE GATE and/or online.**
- No dogs(allowed at all due to PRARG Bylaws) or horses with signs of illness are to be brought into grounds.
- Do not share equipment, including food and water containers, or share equipment between horses including the use of communal horse water troughs
- Participants are responsible for cleaning up manure from yards and placing it in designated areas. Please use your own rakes/shovels.
- Participants are required to advise the event organisers immediately if a horse is sick. Stop all non-essential contact with the sick horse. Do not allow children to have close contact with the sick horse.
- Participants are required to advise the event organisers if they are leaving the grounds with a sick horse.
- Anyone handling horses needs to wash or sanitise hands between contacting different horses.
- Yards at maximum. If you have a yard please don't park inconsiderately when you have no horse attached to your float/truck.

**IN ADDITION:**

- Toilets will be available and will be regularly cleaned
